As our collaboration with Savoye continues, we form a win-win partnership, each learning from the other's work.

SavoirsPlus brings together three social and solidarity-based cooperative enterprises (Sadel, LIRA, and NLU) specializing in the distribution of school supplies, educational materials, and children's books. The group operates through three warehouses: Brissac-Quincé (49) for stationery and books, Monéteau (89) for creative leisure and stationery, and Loriol-sur-Drôme (26) for early childhood products, educational equipment, and oversized items. Each year, it processes 250,000 orders and three million order lines through mail-order sales and five physical stores.

In 2012, facing saturation at its former logistics site, the company invested in a new 14,000 m² warehouse in Brissac-Quincé and implemented an automated logistics solution designed with Savoye, including a WMS and several order preparation stations. This modernization marked a major shift in the group's logistics performance.

This transformation enabled SavoirsPlus to better handle the seasonal peaks linked to back-to-school sales, which account for over 75% of its annual revenue. With streamlined and automated processes, the group can quickly scale its workforce and ensure reliable processing times even during high-demand periods.

In 2018, SavoirsPlus became a worker cooperative (SCOP), fully integrating its three entities. This shift encouraged the mutualization of tools and processes, including WMS deployment across all sites and the addition of a dedicated preparation line for early childhood products at Loriol.

As a result, the company significantly reduced its error rate, improved stock reliability, and continues to optimize and automate its operations.
